At a town board meeting of Dunn Township in Otter Tail County Minnesota, held on the 13th day of March 2017 at 7:00 p.m. at the town hall in the said township, Supervisors Kvare introduced and moved the adoption of the following Resolution, which was seconded by Supervisor Herseth and unanimously adopted by the town board of supervisors.

Whereas, Minnesota Statute 160.05 authorizes a town board, as a road authority, to establish and maintain town roads for the benefit of the public, and

Whereas, Dunn Township in Otter Tail County, Minnesota, contains a number of roads; and

Whereas, Dunn Township declares a number of these roads as town roads and maintains said roads; and

Whereas, these roads have been used by the public; and

Whereas, roads have been repaired and maintained for in excess of six years

Now, Therefore, BE IT RESOLVED THAT THE EXTENSION OF SUNSET BEACH TRAIL IN SECTION 29 OF DUNN TOWNSHIP BE ESTABLISHED AS A PUBLIC ROADWAY IN DUNN TOWNSHIP AND AFTER AUTHENTICATION, THE ROADWAY SHALL BE VERIFIED AS A RECORDED TOWNSHIP ROAD.

Dunn Township does hereby adopt this resolution by a 4-0 vote of the five Board members. Supervisor Seifert was absent.

Old Business:

- 1. Fadness Stairs update: No new information at this time.
- 2. Fire Dept. meeting update Herseth/Dalman: R. Herseth reviewed the information received at the Pelican Rapids Fire Department meeting. The need to replace some SCBA equipment. They applied for a grant to help with the replacement equipment and did not get that grant. They have been setting aside \$10,000 annually to go toward the breathing apparatus and will continue doing so to pay for the equipment over time.

They replaced a tank on the Wild Land Truck. They mention road clearances on some township roads. It was determined that the roads in question are private roads and not maintained by the township. Broadwater Beach road and Senns beach road were mentioned. Dunn township share of the fire department expense has gone down from last year partially due to a large mutual aid payment made to the department by a mutual aid department. The fire department stated that they have an ISO (Insurance Services Organization) rating of Seven in the rural area.

- 3. Survey update –R. Herseth: Fish Lake Road will be surveyed from Kohler Strom Resort to just past Dirk Lenthe's property to reach a recorded section of roadway.
- 4. Zoning Ordinance review update –C. Kvare/R. Herseth:C. Kvare asked if the township should adopt the County Zoning Ordinance now or wait until they have made changes. After discussion, C. Kvare made a motion to forward a request to the Annual Meeting recommending the adoption of the Otter Tail County Zoning Ordinance as it applies to platted developments outside of the shore land management jurisdiction. Seconded by R. Herseth. The motion carried
